Dear Mayor and City Council of Watsonville,

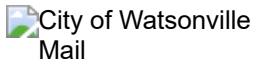

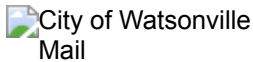

My name is Alondra Ramirez. I live in Watsonville, CA . I'm currently attending school at SOS and I have lived in Watsonville my entire life. I have three older sisters and a younger sister, niece and nephew who are currently attending school at Bradley Elementary. They walk every morning to catch the school bus, which tends to worry me knowing that not all streets have proper sidewalks. Walking out on the street has become more and more of an issue as our population grows. Although I don't walk through downtown very often, I do walk on streets in Watsonville. With no sidewalks while walking I can feel the cars speeding right by me.

It hasn't improved so I tend not to walk when I don't have to. There are many pedestrians out walking. While 59 % drive, 32% walk to and from the downtown area, and drivers need to be cautious (Downtown Watsonville Complete Streets Plan, 2019). More sidewalks and wider sidewalks will help, but drivers still need to be aware of their surroundings.

During the past weeks in class we have been discussing the Downtown Watsonville Complete Streets Plan. Sidewalk improvement is really important to me as it immediately affects my family. I also like the high visibility crosswalks drawing attention to the pedestrians. I support more bicycle lanes. I believe if bicycle riding becomes safe in town it can reduce the numbers of cars.

Dear Mayor Estrada, Mayor Pro Tempore Garcia, and Watsonville City Council Members,

I am writing on behalf of the Ow Family, owners of 555 Main Street and numerous other properties in Watsonville, regarding downtown's Complete Streets Plan. As a land owner in the area of interest, we support improvements that will allow for a safer, more vibrant, and more environmentally friendly downtown. We believe that Watsonville's historic downtown core is on the verge of a renaissance, but intelligent planning and actions are needed to help it fulfill its potential. We believe that making downtown friendlier to pedestrians and other forms of non-car transportation, such as bicycles and scooters, while enacting new zoning for the area that will allow for greater density, housing, and flexibility in project design will allow downtown retailers and restaurants to thrive and attract more businesses and residents. We also believe that if Watsonville and California are going to hit their climate change goals there will need to be a move away from car trips, especially single-occupant car trips in internal combustion vehicles. The Complete Streets Plan could help with this, as could upzoning downtown to allow for more housing, reducing parking requirements, and helping to recruit businesses to the area.
